#### INTRODUCTION

With the rapid pace of construction activities in Singapore, great emphasis has been placed on the construction industry to enhance productivity and quality. Workers' training is the key to achieve this goal. These courses are designed to train practicing tradesmen and foremen to meet the needs of the industry.

#### **COURSES OFFERED**

- Familiarization Course (FC) and Skills Assessment (SA) leading to Coretrade registration.
- Training leading to Skills Evaluation Certificate Knowledge
  SEC(K).
- Express course leading to 2nd SEC(K) To register under Multi-Skilling Scheme.
- All trainees undertaking above courses will be assessed by BCA.

#### **COURSE CONTENTS**

These are practical and theory-oriented courses. The lessons comprise workshop practicals, classroom lectures and video instructions. It teaches the general knowledge on ceiling and drywall installation as well as the practical preparation of suspension and grid components, fabrication of grid work and installation ceiling panels. Trainees will be assessed by BCA.

- Methods of fixture installation and tools
- Good practices in suspended ceiling installation and safety
- Practical workshop on exposed grid and cell type ceiling
- Practical workshop on clip-on grid ceiling
- Practical workshop on semi-exposed grid ceiling

#### **ENTRY REQUIREMENTS**

- For SEC(K), candidates must be Singapore Citizens, Singapore Permanent Residents or holders of valid work permit.
- For Familiarization Course/Skills Assessment:
  Candidates must have SEC or SEC (K) certificate and minimum of 4 or 6 years of construction work experience in Singapore as Tradesman and Foreman respectively and eligibility as assessed by BCA.
- Must be able to understand and communicate in language of instruction.

### **CERTIFICATION**

Upon successful completion of the course, participants who have passed the BCA tests will be issued the relevant certificate or CoreTrade Card in Suspended Ceiling Installation (Acoustical).






# CoreTrade Online Registration at BCA Website
